You will also be aware that in a Statement of 14 March 2023, the President of the Fair Work Commission confirmed provisional views expressed in an earlier Statement of 24 February 2023, that AM2020/99, AM2021/63 and AM2021/65 – Aged Care Work Value Case, must be dealt with by an Expert Panel, once the amendments to the *Fair Work Act 2009* as a result of the *Fair Work Legislation Amendment (Secure Jobs, Better Pay) Act 2022* came into effect on 6 March 2023.

Accordingly, the correspondence will be further considered after the President has reconstituted the Full Bench in accordance with his Statement.
